All activities will center around Braitto's Marina located at the end of the Buckingham Peninsula on Clear Lake. Address, phone numbers and directions to Braitto's Marina are on next page. Boat launch and overnight docking is safe and provided at no charge to OPTREX attendees. All training and other meals will be held in the Konocti Bay Sailing Club (KBSC) Club House and the outdoor, covered "TIKI HUT", both of which are adjacent to restrooms, launch ramp and docking facilities at Braitto's Marina. We are grateful for the generosity of Braitto's Marina and the KBSC for offering their facilities for this Operational Training Exercise. We expect all attendees to conduct themselves in a manner consistent with the United States Coast Guard Auxiliary and to be respectful of all personnel as well as the facilities and areas in which you will be operating.

Friday June 1, 2012

A continental Breakfast will be served. Cost is one-time \$5.00 for all three days. Reservations are required. Registration will begin at 0800. Please check in with Dan Fish, USCGAUX 11NR-08-08 FSO-FN upon arrival. We will be offering training for those members who would like refresher training prior to qualification or re-qualification on Saturday. Facilities will be available and we will also be offering shore side training in 2012-8 Hr. TCT, 2012-1 Hr. TCT and 2012 Operations Workshop. Lunch will be prepared and served by USCGAUX AuxChefs. BBQ Hamburgers and Cheeseburgers along with chips and drinks will be available at a cost of \$7.00 per person. Reservations are required. A dinner, prepared by AuxChefs, consisting of BBQ Ribs or Chicken, Baked Beans, Green Salad, Dessert and drinks will be available for dinner at a cost of \$15.00 per person. **There will be no alcohol served with the Friday night dinner nor allowed prior to the SAR night exercise.**

Saturday June 2, 2012

A continental Breakfast will be served. Cost is one-time \$5.00 for all three days. Reservations are required. 1 Hr. TCT, 2012 OPS Workshop and dockside and on-the-water QE exams. A deli lunch (\$8.00 per person) will be served at "TIKI HUT"/KBSC Club House and will be available from 1200 to mid afternoon in order to accommodate those who are participating in on-the-water qualifications or re-qualifications. The Division meeting will be held at 1430-1630 at the KBSC Club House. For those attendees who will not be attending the Division meeting, there is a Steele Winery Tour scheduled between 1400-1600 at a cost of \$5.00 per person which covers tour cost and tasting. A BBQ Rib Eye Steak or Chicken dinner with baked potato, salad, French bread and wine will be prepared by AuxChefs and offered at \$20.00 per person. Reservations are required. Directions to Braitto's Marina from downtown Lakeport, CA

1. From Downtown Lakeport, CA startout going South on North Main St. toward 1st. St. 1.8 miles.
2. Stay **straight** to go onto Soda Bay Rd. 9.9 miles. (You will pass Zino's Ristorante' 7.8 miles on left).
3. Turn **left** into Buckingham and stay left to go onto Westlake Rd. 0.6 miles.
4. Turn **right** on Orchard Dr. 0.2 miles.
5. Turn **left** on Eastlake Dr. 0.8 miles.
6. Arrive at Braitto's Buckingham Marina.

Directions to Braitto's Marina from SF Bay Area or CA I-5

1. Find your way to the city of Lower Lake, CA (intersection of Hwys. 53 and 29. From the Bay Area via the Napa Valley use Hwy. 29. From I-5 at Williams travel West on Hwy. 29 to Hwy. 53 South. Drive 7.5 miles.
2. At Lower Lake, if traveling North on 29 turn left on Hwy. 29. If traveling South on 53 turn right on Hwy. 29. Continue on Hwy. 29 towards Lakeport 7.6 miles.
3. Turn right on Soda Bay Rd., Hwy. 281. Drive 5.9 miles.
4. Turn right into Buckingham at Crystal Dr. Keep left 0.1 miles down hill to stop sign.
5. At stop sign proceed straight through intersection stay to right and continue North on Eastlake Rd. 1.5 miles.
6. Arrive at Braitto's Buckingham Marina.

Directions to Steele Winery from Braitto's Marina (Travel time approx. 22 min.)

1. Exit Braitto's Marina going South on Eastlake Drive 0.8 miles.
2. Turn **right** on Orchard 0.2 miles.
3. Turn **left** on Westlake Drive 0.6 miles.
4. Turn **right** onto Soda Bay Rd 6.5 miles.
5. Turn **left** to stay on Soda Bay Rd. 1.0 miles.
6. Turn **left** onto Stone Dr. 0.8 miles.
7. Stone Dr. becomes Big Valley Rd. 0.4 miles.
8. Stay **straight** to go onto Thomas Dr.0.4 miles.
9. Take 1st **left** onto Argonaut Rd. 0.04 miles.
10. Take the 1st **right**. 0.02 miles.
11. Arrive at Steele Wines

WARNING! Quagga/Zebra mussel sticker requirements:

(Braitto's Marina is authorized to perform the necessary screening and issue Quagga Mussel boat and trailer stickers)

All vessels and their trailers must display the proper mussel inspection sticker before launching in any body of water in Lake County, as required by Ordinance NO. 2936. Violators are subject to a minimum fine of \$1,000.00. You can find the nearest location for vessel screening posted at public launch ramps, or by stopping by your closest bait and tackle shop or resort.
